Covid-19 Protocols

Chief Stumpf explained that coronavirus protocols had been increased and updated to be in line with the CDC and Colorado Public Health due to firefighters testing positive for the virus. After a second firefighter tested positive the District escalated the protocol to a Level 3, which required shifts were to be in pods with no intermingling, no shift changes, contactless shift change, and no one sharing sleeping quarters. The administrative office was also closed.

Civil Unrest Task Force / Everbridge Notification

Chief Stumpf stated that the civil unrest task forces were built on Everbridge and complete prior to election day. Chief Charles stated that LETA will also be able to provide help with emergency responses.

Reserve Firefighter Recruitment

Ms. Wilson stated that a reserve firefighter recruitment was currently underway. Applications were due on November 20th, with skills assessments scheduled for November 30, and Oral Boards scheduled for December 1.

Stephen Charles, Fire Chief

James Vincent Group Fund Balance Study

Chief Charles noted that a conservative approach was taken by reducing gas & oil along with eliminating wildfire revenues due to the inconsistency from year to year. The Group was recommending a fund balance of 35%.

President Dan Hershman noted that it was important to have a fund balance.

Chief Charles stated that 3% that tabor requires was a restricted fund balance along with impact fees. He stated that after the first of the year the Group could present to the Board.

Fire Station 3 / Cost Increase / Location Options

Chief Charles stated that an IGA was completed with the Town of Berthoud to house the building on Town property; however, during the plan review process the site was determined to be in a flood zone. Due to this, he reached out to Aims Community College as they owned ground west of that site. He planned to discuss a lease option or the possibility of purchasing a portion of the land. If those were not options, then the building would be sold, and all money spent on the building would be recouped.

High Performing Government Map

Chief Charles stated that he had been working with Chief Stumpf to outline sustainability and continuity of services within the high performing government map.
